

MEDIA CONSENT FORM

I hereby consent to the use of an interview with me, to be produced by:

I understand that this interview will be used only in the program _____
_____ and for no other purpose whatsoever.

The right to the use of the interview is granted worldwide and in perpetuity, but only for use in the program specifically named herein, and not in any other manner whatsoever, including successors to this program or re-edited versions of this program, except insofar as translation may be added for use in non-English speaking markets.

I consent to the use of this interview only if I am not held up to ridicule, disparaged, described as a liar or in any way as a mistaken, deluded, ill or confused person, or cursed or in any way portrayed in a manner that I consider damaging to my personal dignity, and only if no other person in the program offers an opinion that any statement by me is false, deluded, mistaken or in any way incorrect.

I consent to the use of this interview only if the interview is not edited in any way to change the meaning of my statements, or to make it appear that something I said was foolish, incorrect, or in any way different from my original meaning.

I consent to the use of this interview only if a full and complete copy of the original videotape of the interview in its complete, original and unedited form, is guaranteed to be made available to me at any time solely at my request and free of charge within the next three years from the date of this consent. You agree to keep a copy of this interview for that period of time at no charge to me, and to provide it to me at my request immediately, by express courier or fastest available package transport, upon receipt of my demand for it.

You agree that any litigation being brought by me as a result of your use of my interview will be adjudicated in my home jurisdiction or other jurisdiction of my choice exclusively, and in the manner of my choice, whether it be in a court of law or by arbitration, and that you will abide by the results of any arbitration, with the understanding that, if I choose arbitration, the process will abide by the National Arbitration Code of Procedure, except that I will have the sole and exclusive right to choose the venue for such arbitration.

You agree that by exposing my interview in the public media, you accept the terms of this limited consent and cannot claim that the individual signing the consent on behalf of the company later exposing the interview did not have the authority to do so.

I affirm that I have signed and will sign no other consent for the use of my interview, and that it is my intent, by signing this consent, to prevent the use of my interview in a way that I consider harmful to me.

You agree to inform me in writing of your intent to expose my interview to the public no later than twenty four hours prior to its exposure. You agree to provide me with a copy of the finished program as it was exposed, at my request and at your expense, up to three years after the date of the exposure of said program.

This agreement is part of any contract for my compensation, and nothing in that contract may be held to change this agreement in any way whatsoever.
